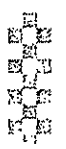

Thank you for the opportunity to serve on this board. I would be honored to do so. My Oregon troll permit number is #62570 and my boat license # is 45865.

I feel I am qualified to serve on this board for the following reasons and will attempt to familiarize you with my history in the fishery. I am 68 years old and have been active in the fishery since the 1940's, as my father was a salmon troller. I have rarely missed a salmon troll season since early boyhood. I was graduated from Oregon College of Education in 1968 but three years later went fishing fulltime until 1990. I have a 200-ton USCG Master's License (retired) as well as being a USCG-certified Marine Safety Instructor.


In 1990, I started a boat brokerage called Oregon Coast Marine Services and operated it until 1997, when I returned to commercial fishing. I brokered the sale of commercial and recreational boats and did my own marine documentation paperwork. In addition to doing the ownership transfers of other boats, I began selling and transferring the ownership of fishing permits, both state and federal, as more limited entry programs came into existence.

In regards to transferring Oregon Troll Permits, it could sometimes be difficult because of changing personnel and their interpretation of the transfer regulations. The bottom line at that time always came down to "the intent of the law," and sometimes a person such as Terry Thompson, now a Lincoln County Commissioner or Bob Jacobson, then a OSU Marine Agent, needed to be consulted, as they were both instrumental in forming the Ocean Troll Limited Entry program. However, I feel today the program is firmly established.

I am actively fishing still, and own the 45-foot vessel F/V Silver Sea, moored in Newport. At present, I am recovering from surgery, but hope to be out fishing as soon as possible.

I would consider it an honor to serve on this review board and feel I can bring much experience to the proceedings.


