My biggest concern is regarding "parties."

As I understand, the current holder of a reservation (blind reservation) can take up to three people with him/her fulfilling the requirement of 4 hunters to a blind (I know roam units have a maximum number of hunters per area, such as Foot Bridge has a limit of four).

I would be all for this new method if this standing guideline can be maintained.

Thus, a group can take the individual members and have each apply separately allowing for better odds of the group hunting in a blind location together.

Good to speak with you at the Waterfowl Festival. Regarding a couple of things: I am puzzled about why Ron Saylor would care about the snipe season. Just a guess, but he likely has never shot one. At least during the many years I have known Ron, about as far as he would be willing to walk would be from the living room to the kitchen to get a sandwich.

As for the Eurasian, yes, they are still largely in urban areas. But I think they are now starting to spread out, slowly. As just one example, the population at Perrydale has now reached our place, two miles west. And they are certainly being shot "out of season." There was once a good number down the road at McCoy. A fellow let his grandson shoot them, and they are apparently all gone, or at least I don't see them. And over at Ballston, there is a farmer who allowed a father and son shoot them around his grain building, and he told me that they shot over 30 last December/January.

As you know, I think it is a total lack of common sense not to have a controlled season on the dove. Like it or not, your Department is very much a business, based around selling hunting and fishing licenses. Any business needs products to survive. In western Oregon, aside from waterfowl and snipe, you have no products to offer. So is there any question why the sales of hunting licenses continue to drop off? I think your Department should view the Eurasian as a gift in an otherwise bleak setting.

I understand that the ODFW is looking at potentially opening the stretch of the Columbia that is currently closed. Personally I think this is a wonderful idea. As a waterfowler I find that it is increasingly difficult to find access to hunt. Growing up in the valley I've seen many areas that I hunted as a kid become unavailable through development, clubs, and refuge system. We hunted the Baskett Slough area, throughout the Wapato lake basin, and at Earhart Steinborn's which is now part of the TWR. If the waterfowling culture is to be preserved it is critical that access to hunting areas be available. Youth is the critical component of all our outdoor activities and if we can't give them an opportunity to experience hunting and fishing on public land the license numbers will continue to dwindle. Clubs are great for individuals that can afford them but Sauvies Island is a perfect example of the clubs vs. public hunting and it is easy to see the demand for hunting access by the incredible amount of usage at Sauvies.

I am always in favor of allowing the longest season possible even if it means reductions in bag limits and I think most hunters enjoy the days in the field and would agree.

Regarding the Columbia River Refuge I favor opening the remainder of the refuge for bird hunting as this would open a large area to the public and provide quality hunting opportunities.

Since I don't hunt at Sauvies Island and live at the north coast and am not familiar with the late season South East OR goose situation I don't feel I should make any comments on these issues.

Numerous land owners in Klamath County no longer allow hunting in the Spring to General Public as they are requesting Trespass Fees or have it leased out to Outfitters. The Public Land addition to the Klamath hunt was nice but very Non-Productive as far as quality hunting. It also significantly altered some of the Private Property that allow hunting. Brandon,
Here is my feedback on the Migratory proposals:

- Re: Duck season opener

I favor the Second option: *Open Zone 2 the week after rifle buck opener (October 11) and maintain the split duck openers (Zone 1 would open October 18), necessitating a reduction in season length in Zone 1* Open Zone 2 the same day as rifle buck season (October 4), maintain the split duck openers (Zone 1 would open October 11) and utilize all 107 days for each zone.

I strongly oppose the third option that shortens zone 1 season: Open Zone 2 the week after rifle buck opener (October 11) and maintain the split duck openers (Zone 1 would open October 18), necessitating a reduction in season length in Zone 1.

This option penalizes the Zone 1 hunters that do not participate in the Deer opener for no biological or statutory reason. I dont see it as a problem if some hunters have to choose between two attractive hunting opportunities. Limiting choices is not a benefit to hunters.

- Re: Columbia refuge. I support expanding the areas of the columbia refuge that are open to hunting to open the remainder (Celilo to Arlington) of this refuge to game bird hunting to add additional waterfowl hunting opportunity

- Re: Sauvies Island Eastside check in proposal. I support the new Option 2: Modified Eastside Reservation System. It works well at other refuges and would be a benefit to the Sauvies Island system.

Southeast Oregon Late-winter Goose Hunts - no opinion

The Columbia River Refuge..... The Department will be asking the Fish and Wildlife Commission to adopt a proposal to open the remainder (Celilo to Arlington) of this refuge to game bird hunting to add additional waterfowl hunting opportunity along the Columbia..... YES!!!!!! This would be a great opportunity and open up some fantastic opportunities to waterfowl hunting. There is significant distance from west side metropolitan areas so hopefully the area will not be overrun. This is a great public resource that would be fantastic for public hunters.

Sauvie Island Wildlife Area Eastside Waterfowl Reservation Check-in System..... we will be asking the Fish and Wildlife Commission to adopt a proposal (option 2 in the attached "Sauvie Island Reservation System" document) to modify the system beginning with the **2015/16 hunting season...** YES!!!!!! This is outstanding and has been needed for a very long time. This will bring equity back into the system.

One other change I would love to see regarding Sauvie East Side is for a way to prevent hunters who get drawn and land a "premium" blind from cycling every buddy they have in town throughout the entire day. You see the same trucks parked week after week in the Johnson unit. I have been at the check station many times when guys pull up at noon (not on the waiting list) to take a blind. What is happening the original hunting party (or a portion of the party) will limit out, call their buddy, the buddy then comes out and takes a the spot. This rotation keeps up all day. There needs to be a provision that anyone not in the original hunting party needs to go onto the wait list. This will prevent abuse that is going on.

- Yes on opening up the Columbia River Refuge to hunting (Celilo to Arlington)
- Option 2: Modified Eastside Reservation System
In order to make the hunt area selection process more equitable ODFW is considering a check-in sequence based on a pre-assigned preference number similar to the systems used at Fern Ridge Wildlife Area and Umatilla National Wildlife Refuge.
- I also think that Sauvie Island should adopt the 25 shell rule like most other management areas across the state. This could control sky busting and make the management area even better than it is. This would take some enforcement but would be worth it in the long run.

Doves: Love it, under harvested bird and with the new Eurasian invader will get more folks opportunity to kill these, may even get some incidentals during duck season

For the Start this year my suggestion is to Start both on the 11th or do the split with Zone 2 on the 11th and Zone 1 on the 18th.

Late Winter Geese, don't really partake but it makes sense, these birds are not around December January anyway.

For the Columbia river, all for opening it up. Always see rafts of ducks out there and the Geese are all over those islands.

Sauvie Island: Anything is better than the current program. Would frankly rather see the poker chip program like the west side but this sounds like it works pretty well at Fern Ridge.

Has there been any discussion on NW Permit Goose? Need to change the boundaries, Duskie shot all over the place in the General Zone east of I-5, hopefully the cackler limit addressed back to 4 if possible, a lot of days where we only see them. This is an atrocious system but I don't ever see it changing in the current political environment. Too bad it is a underutilized resource and great hunt opportunity that no one wants to mess with because it's so complicated. I shoot geese 5 minutes from my house and have to drive 23 miles (46 miles round trip) to check them out.

Brandon, Thanks for sending this along. I certainly hope, now you have extra days for doves, that you will seriously consider a split season! As I am certain that you have seen for yourself, we have good (sometimes large) numbers of mourning doves in the valley in November (early December?) I mentioned this to Bales several times, but as with everything else I ran past him, got nowhere. In the late 1950s Chet Kebbe had a (15 day?) November season. I think that was because the Federal framework allowed 45 days. At any rate, I had some good days with November doves. But he only had the season for one year. When I asked him why, he said that some hunters had shot up a pear orchard in Medford. And that was that. Several other fellows I know have mentioned November doves, going so far as to suggest splitting the September 30 days in half. I think you could give us some good days. Hope you will. Thank you for putting out the information on the waterfowl season options.

It has been made clear that this situation only occurs every 5 or 6 years; that and the fact that next years framework (2015-16) will allow the season to end on January 31st, 2016, Option 2 is the most equitable for all hunters.


East side deer hunters and waterfowl hunters could still Hunt both openers and west side waterfowl hunters who like to hunt the east side, primarily Summer Lake, can still do so. The option 2, opening both Zone1 and Zone 2 on October 11th gives both zones the full 107 day season and the number of people that would actually have to make the "one-or-the other" choice would probably be reduced.

The Sauvie Island Option 2 for the 2016 season does appear to be the most equitable opportunity for waterfowl hunters that draw the permits and should alleviate the need for the 1or "2" day reservation lines.

The new 60 day dove season and 15 bird bag is a good addition to our hunting opportunities. Please, for next years season, petition the USF&W Service for the ability to split the 60 days into an early and late season as so many of the other states already have. We often see more doves staying in western Oregon in late December and January than we do in the September seasons of past.

Appreciate your efforts to sustain our birding opportunities.

With regards to the possible changes to the reservation hunter check-in system for the Eastside Hunt Area, I support Option 2: Modified Eastside Reservation System. This change would make the system more equitable to all who hunt the Eastside. I dislike having to spend the night in the reservation line to get a good hunting spot. I would much rather know that when I draw a unit, I have the second or third choice rather than having to get in line 12 or 18 hours early. Besides, the reservation and non-reservation line are really not set up for overnight camping.

I also recommend that the number of fixed blinds in the Mudhen and Hunt units be reduced and the remaining blinds spread out to reduce conflict between hunting parties. Too many times it become a shouting match or one party shoots just to disturb another party's hunt. I recommend that some of the roam units, such as Dead Willow and Foot Bridge be converted to fix blind units to make up for the reduce number of blinds in Hunt and Mudhen. I dislike the roam units because there always seems to be hunting parties that set up too close to one another. One option would be to set the blinds similar to Johnson where the hunting party would be allowed to set up within say 50 yards of a fixed marker.

I understand there are no guarantees in life but many people in our society want guarantees. Life does not need a reservation for every event. Public land duck hunting takes work and commitment. Those who put in more work generally get a better benefit. That is how it should be. I am tired of listening to someone from Portland whine about getting up early to wait in line. I live in Salem and have to get up two hours earlier just because I live farther away. There should be a special line for "out of towners" to be fair as I have to drive farther than those who live in Portland.....

Also the logistics of coordinating dozen blinds at Fern Ridge is simple, small parking lot, small numbers of hunters. Try that at SI with the large numbers of hunters and I believe you will have a mess. The guy with a guarantee is at the back of the line and everyone waits while he works his way up front. You will always be late or require an earlier start.

In short, if there is that much pressure for a guaranteed reservation, take a unit like Racetrack and make those blinds your for the day, like they were in the 70's. That way there are some guaranteed blinds but most of the units stays the same.

Thanks for the opportunity to comment on the various waterfowl proposals. The only proposal I have a comment on is with regard to the Zone 1/Zone 2 opening dates. I'm in favor of "Option 1" (Open Zone 2 the same day as rifle buck season (October 4), maintain the split duck openers (Zone 1 would open October 11) and utilize all 107 days for each zone) for the following reasons:

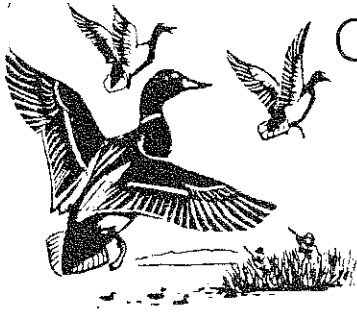
1. Safety: With fewer hunters in the marsh without those who decide to deer hunt instead, the safety factor goes up for those in the marsh. It would be interesting to look at the number of complaints of being pelted with shot at Summer Lake the last time this scheduling conflict arose, compared to years in which the deer opener preceded the Zone 2 opener--my guess is there was less crowding in the year there was a scheduling conflict than other years, and hence less of a safety issue with hunting parties setting up too close to one another.

2. Waterfowlers shouldn't be an "after thought"-- At the outset, the choice as set up suffers from a false analogy--that "openers" are of equal value, and hence "interchangeable" in a negotiation among hunters with generally common interests. Openers are not of equal value--a bargaining chip if you will--to trade off among "hunters"--some of who don't care to ever deer hunt. Also, we don't have a common interests with the deer hunters. We are waterfowlers. We hunt them in Oregon, Washington, California, Idaho, Montana, Alberta and Saskatchewan. We chase cacklers in the Valley, sea ducks on Puget Sound, and mallards on the Canadian prairie. I don't try to tell deer hunters when they should start their season and deer hunters shouldn't dictate when waterfowlers start their hunting season. Life will always present conflicting commitments--the waterfowl opener, or my kids' soccer games, or my second-cousin-three-times-removed's wedding...You get the picture. You'll get gripes from the deer hunting crowd, and I anticipate that you'll get more comments from these types, but I think it's bad policy to let "majority rule" here. Let's not make the waterfowler an afterthought. Keep waterfowl season for the waterfowler and maintain separate Zone 1 and 2 opening dates.

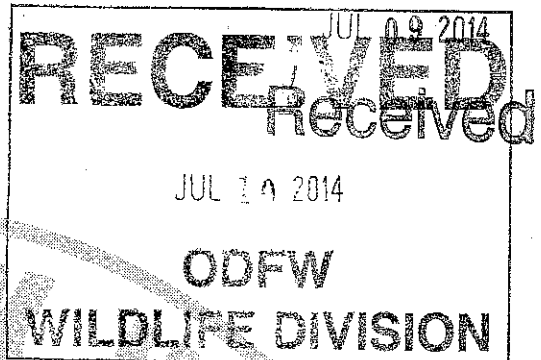



We forwarded the email on the proposed duck season opening dates to our Ducks Unlimited supporters and received the following opinions;

Option #1- Open Zone 2 the same day as deer season (October 4), maintain the split openers (Zone 1 would open October 11), and utilize all 107 days for each zone.

68.7% of our responders voted for this option.

Option #2- Open both zones on the same day (October 11), the week after deer opener, and utilize all 107 days for each zone

22.9% of our responders voted for this option.

Option #3- Open Zone 2 the week after deer opener (October 11) and maintain the split openers (Zone 1 would open October 18), necessitating a reduction in season length in Zone 1 from 107 to 100 days

8.3% of our responders voted for this option.

Gents, can you enlighten us on the rationale for the some of the proposed changes in game bird seasons and bag limits?

I learned about the dove proposal a year ago from a bio who is very up on doves and doesn't support it. He stated there's no data to indicate an increase in mourning dove populations. One of your predecessors used to comment that the dove season doesn't matter because all the birds are gone by the opener anyway, but he didn't live in southern Oregon, where we have resident doves all year, but nowhere near the numbers we have in September. Although I have no idea why 10 doves a day for a month isn't enough for anyone, the bag limit doesn't bother me that much because I don't know anyone who limits anyway. What does concern me is continuing to pound a smaller resident population for another month when there are plenty of other game birds to chase in October.

Also, has OHA asked you gents for the population data to support the expanded turkey and forest grouse opportunities being proposed? And has disturbance to eastern Oregon's wintering wildlife been considered in the latter case? I can recall that the OHA Baker Chapter led a push to close chukar season early during the harsh winters in the early 90s because exhausted deer were being disturbed.

Any insights for me to take to our board meeting Saturday?

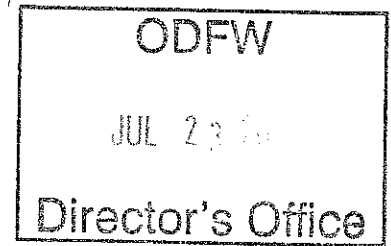

Dear Chair Levi:

Thank you for the opportunity to provide the following comments. These comments are my own and do not reflect the views or opinions of any groups I am affiliated with.

It is my understanding from conversation with local and headquarters ODFW staff and attendance at a subsequent public meeting that the Commission will soon hear a proposal to open the longstanding Columbia River Waterfowl Refuge to hunting.

I would encourage the Commission to make that change for the following reasons.

First, there are no identifiable biological or social negatives that would prevent opening approximately 47 miles of the Columbia River to waterfowl hunting. Access to that reach of river is currently very limited by railroad and interstate freeway rights of way. That will not change if the refuge is opened to hunting and hunters will have to work hard to access the area once open. Pressure will not be heavy due to the lack of access.

Second, the area is rural in nature and there will be little opportunity for adverse interactions between hunters and the general public.

Third, opening the currently closed area will provide for greatly increased waterfowl hunting in our local area, an opportunity we currently find in short supply due to various city limit restrictions, state park boundaries and generally poor access to the Columbia River.


And finally, I think it would certainly be a good idea for the Commission to take action to provide more opportunity for hunting, given the serious budget problems and potential license fee increases you are currently facing. Any action that will sell more licenses and waterfowl stamps will be a good thing.

Additionally, I feel that the Commission should take unilateral action to open the Columbia River Refuge if Washington fails to do so. As regards hunting on boundary waters, I am sure

you recall there is a recognized state line in the Columbia River and hunters have to hunt on the side of the river they are licensed on (assuming they have only one license). This is, of course, different than angling regulations on boundary waters where either state license is valid up to the shoreline of either state, which is likely why the states seldom take unilateral action on angling regulations.

Again, thank you for the opportunity to make these comments.

By changing this you will be changing hunting history and reducing the quality of the hunt. I understand the "I want it now" part of option two, but that's not part of Hunting.

For what it is worth, I like the idea of having the duck opener in zone 2 open Oct 4th. The Deschutes River flows are ramped down in October which eliminates the water in the sloughs where the ducks hold. (please see the below water graph)

Currently Wickiup Res is at 45% and lower than average, indicating that the Deschutes ramp down will potentially occur earlier than last year.

After the river flows are reduced the ducks congregate at Drake Park in Bend and travel east to the fields of Alfalfa to feed. The best hunting is had when the river is over 1200cfs when the ducks have the river sloughs as feeding and dabbling areas. This scenario is most probable early in October.

2014 Migratory Game Proposals

This year the Fish & Wildlife Commission's annual meeting to adopt migratory game bird seasons and regulations will occur on August 1, 2014 at our Salem Headquarters Office. There are several proposed changes or considerations for change where we need your input. Additionally, your ideas on anything related to the game bird regulations or game bird hunting are always welcome!

Migratory Game Bird Seasons

The US Fish and Wildlife Service has preeminent authority for setting frameworks for migratory game bird seasons and bag limits. They will not set frameworks for waterfowl until late July, however, this season they have approved a new framework for mourning doves which will allow Pacific Flyway states to offer more hunting opportunity than in past years. Specifically, Oregon is allowed to and will propose:

- A 60-consecutive day mourning dove season with a 15 bird bag limit. Under this new framework Oregon will propose a mourning dove season from September 1 – October 30 with a bag limit of 15 per day.

Duck Season Opener – Split or Concurrent Seasons for Zone 1 & 2

Oregon traditionally holds a split duck season with Zones 1 & 2 opening a week apart, unless the federal frameworks would force the Zone 2 season to open the same weekend as rifle buck seasons. When this has occurred in the past, we have traditionally held a concurrent statewide duck opener the weekend after the rifle buck opener (last in 2008). This season, if Oregon is allowed to have a 107-day duck season we would be forced to open Zone 2 on October 4, the same day as the rifle buck opener, or hold a concurrent statewide duck opener on October 11. Because of the federal frameworks and the traditional rifle buck opening of the Saturday closest to October 1st, this situation is unavoidable and will occur every 5 or 6 years. We are asking for your opinion on the following possible opening day scenarios:

Mr. Reishus:

My name is Larry Blankenship and an avid (some say rabid) NW waterfowler. Your current chief (Roy E.) is an old friend, hunting partner, etc and knows me well. I want to provide some comments re proposals for the upcoming synopsis. I hope my comments won't be too late to be considered, but I have been out of state for several weeks and just returned and am going thru my 200+ messages.

I am currently on the Board of the Tualatin valley Chapter of OHA and represent the waterfowlers in our region. The consensus I have obtained is that Option 2 is most desirable: I.E., start both Zone 1 and 2 seasons beginning on October 11 and utilize all 107 days available for both zones w/o a break- run them straight through.

My experience is that waterfowl hunters will go where the largest concentration and potential for success appears to be. Everyone I have talked to loves the idea of the 60-day Dove season. The ammo manufacturers should love the added bag limit as well- hunters seem to have a hard time hitting a few doves, let alone 15/day! It just might be time to invest in Remington, Federal, Winchester, etc. ammo!

Late Goose Hunting in Lake & Harney CO's similar to Klamath and Malheur: The general consensus is that is a great idea, and many hunters liked the possibility of potential goose hunting after the regular seasons are over. Since much of the better hunting would be on private lands- perhaps advertising the departments Co-Op agreements and emphasizing the availability of lists and maps could encourage more landowner/ hunter relationships to develop.

Columbia R. Refuge (Opening Col. R Celilo to Arlington): Every hunter I inquired of thought this was an exceptional idea- potentially providing more hunter access and opportunities. We all hope this one gets a favorable review.

SAUVIE'S IS- Eastside Reservation Check-in System: Option 2 starting in the 2015/16 season is most agreeable. This necessary change is a welcome one for anyone who has had to sit in that reservation or worse the Non_res line for one or more days! I first came to Oregon over 35 years ago- I was totally flabbergasted at how that system even worked, so this change has been long-awaited.

Summation: It is gratifying to see ODF & W finally make some serious but welcome changes that seriously benefit hunters and I am personally encouraged that these measures are being proposed and considered. As an OHA Board member, like you gentlemen, I hear the negatives much more than the positives re hunting, access, prices always going up, but "Opportunity" and "Access" going down steadily. Just possibly, some of these measures might start to turn around hunter recruitment. In the past 10 years I have lost four hard-core waterfowl hunting partners- they simply gave up hunting altogether (all were retired but thought that the availability of deer, waterfowl, etc and the lottery type application system was rigged- all just got tired of the added costs and hassle factor.

I realize that manpower costs continue to rise- but many in the hunting fraternity ask, " when is the fees and costs going to stabilize"? Ever since the Sports Pac wa sinitiated many of my hunting partners have been purchasing itas they actively hunted a lot of various species; however as many hunters age- they decide the few opportunities to obtain a tag to hunt isn't worth the Sports Pac costs.

Thanks for taking the time to consider my response to the upcoming proposals and my ramblings.

As stated in the proposal, there are already other refuges that operate the way you are proposing. Leave this option for those of us who prefer this method.

I have been giving additional consideration to the proposal presently being considered to change the Sauvie Island East Side Reservation Process and the more I think about the proposed changes the more I am ABSOLUTELY, 100% OPPOSED to making the changes being considered. There has been a very lively discussion on IFish.net about the proposal with strong opinions on both sides. I believe that if you can, you should very much take to heart the comments that have been posted there.

One of the themes that I'd like to bring to your attention is the repeated emphasis that contrary to what might have originally been thought, the proposal is not widely supported by others like myself who live further away from Sauvie Island and that maintaining the current variety of options (west side chip pull, east side reservation process, and non-res sweat line) provides options for all types of hunters no matter how far they have to travel to Sauvie.

I know that IFish is not totally representative of all Sauvie hunters, but neither will your request for comments be representative of them all. The majority of Sauvie hunters are neither on your email list nor contribute on

IFish. However, it is possible that this discussion will bring to light some concerns that have not been brought up in response to your request for comments. Reading the threads, it is apparent that the same arguments and themes are often repeated in both. The members of IFish have discussions about how to "improve" Sauvie Island repeatedly, and there is very little consensus about what changes should be made except that the most popular change to make is NONE. The majority of comments in most cases support making no changes.

In any case, I respectfully request that you include the comments from those threads as part of my comments regarding the proposed changes to the Sauvie Island East Side Reservation process.

I would also like to suggest that if, when all is said and done you decide to implement the proposed changes, that you either combine multiple units together so that there are more blinds to choose from with a reservation or that you simply offer reservations that can be used in any unit, much like Umatilla does. So, rather than issuing 12 Mudhen, 5 Racetrack, 6 Johnson reservations, etc., you simply issue 25 (or however many you want) East Side Reservations (with picks #1-#25) That will serve to make those latter picks much more useful and very much simplify the application process. It will also aid in resolving the problem whereby under the proposal you will have the prospect of 12 (or more) #1 picks with the possibility of checking in all at once (if you follow the west side model as I expect is planned). This will also reduce the inevitable shift to the non-res line that will result from the current proposal and will allow reservation holders to take advantage of ducks shifting their patterns based on refuge conditions.

Another alternative that I believe offers merit is the suggestion to implement the proposed changes by making the Flights End acquisition operate as outlined in the proposal, rather than the entire eastside. This will allow for an additional option for applicants, thereby providing more options, rather than reducing options for hunters who prefer the current process.

I am writing to express my opposition to the proposed changes to the Sauvie Island Eastside reservation and check in process.

I live in the Salem area, apply for reservations regularly, and hunt the Sauvie eastside 8 to 10 times per year on average. However, due to the travel time and expense involved for me, I only hunt Sauvie when we have a reservation. It is simply not worth my time and expense to travel 1 1/2 hours unless we expect to be able to get a good blind. This also means that I am 100% willing to put in the time and effort to get in line early to improve those odds. Don't punish those of us willing to put in more effort!

There are already two other refuges in Oregon that follow the proposed model (Fern Ridge and Umatilla). They are both a long drive from Salem and both result in the same decision process for me. I apply for reservations at both refuges but only go on those trips if I get a low enough pick. Otherwise, that cherished reservation goes to waste.

I also prefer to drive up the night before, rather than the alternative of leaving Salem at 3am. I get more sleep in line that way and as a bonus get to enjoy the overnight camping experience with my son and hunting partners. Adding a pick # won't change that one bit. I will still arrive the evening before the reservation and camp in the parking area. What it will do though, is reduce the number of times I make that trip. We simply won't go to

Sauvie unless we have a #1 or #2 pick. Depending on results we might simply stop applying if our draws don't warrant doing so.

I am married and I have a full-time job so the argument that this benefits those with families and full-time jobs does not apply to me. If the proposal is implemented it will mean less hunting Sauvie for myself, my son, and my other hunting partners. It will also mean less revenue for the refuge since we simply won't buy those reservations unless they are low enough picks. If I lived closer I would opt for the non-reservation line or west-side chip pull in order to improve my odds of getting a good blind. Either way, reservation sales would decrease.

I would also add that there are logistical problems that will require additional costs to implement the proposed system at Sauvie. I foresee the need to expand the parking area and/or make the check in line wide enough for vehicles to pass one another. Umatilla only gives out 25 reservations each hunt day and only half show up on any typical day. Fern Ridge refuge is tiny in comparison. I can't imagine handling all the reservation holders' vehicles, some with boats/trailers/campers, trying to maneuver in and out of the eastside parking area. Expanding that parking lot will convert refuge land to a parking lot and cost scarce resources to both build and maintain.

Sauvie Island offers viable options for a wide range of hunters. There are options for those who are looking for an easy hunt and for those willing to put in more effort. There are options for those who want to get up late and cruise in right before shooting light. There are good options for those that hunt it occasionally and for those that hunt it frequently. Please don't eliminate the opportunity that Sauvie provides those of us willing to put in that little bit of extra time and effort that the current Eastside process offers. There is nothing unfair about the way it is set up now. The proposed change will reduce my hunting opportunities and cost ODFW more scarce refuge resources to maintain.

I am writing about the anticipated expanding of the Dove season.

Here in Eastern Oregon we get early freezes and occasional cold rain. The doves usually leave our area when this occurs. In other words they check out in late August or early September.

As long as I can remember dove and Dove season open on September 1. What I am proposing is to open dove season on August 15 which will allow us to bag some doves before they fly south.

This means the season would run from August 15 to September 30. Also 10 birds per day is sufficient.
